

ORDINANCE NO. 9-2007

AN ORDINANCE ESTABLISHING A DIRECT TRUCK ROUTE
WITHIN THE VILLAGE OF TILTONSVILLE, OHIO,
WITH THE ESTABLISHMENT AND PROCEDURES FOR IMPOSITION OF
PENALTIES.

WHEREAS, Tiltonsville Village Council hereby determines that heavy truck traffic upon Village streets subjects the pavement upon said street to damage and it is therefore desirable to limit the number of street upon which truck traffic may travel; and

WHEREAS, Tiltonsville Village Council hereby determines that unregulated truck traffic upon residential areas in the Village creates noise, dirt, and vibrations in the homes along said streets, which noise, dirt and vibrations create a nuisance for persons who live along said residential areas; and

WHEREAS, it has been determined by the Council of the Village of Tiltonsville, County of Jefferson, State of Ohio that it is necessary for the Village to establish a designated truck route in order to protect the health, safety and welfare of the citizens of the Village of Tiltonsville, Ohio.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF TILTONSVILLE, COUNTY OF JEFFERSON, STATE OF OHIO:

SECTION 1: No person shall operate a truck, trailer or semi-trailer, excepting 10 ton gross weight or smaller pick up trucks and panel trucks, upon any street in the Village except as set forth in Section 2, 3, 4, 5, 6, and 7 of Ordinance 9-2007.

SECTION 2: Operators of said vehicles must deliver and pick up cargo within the Village of Tiltonsville by entering the Village via Walden Avenue by way of the Farm Lane Exit from State Route 7 and travel by the most direct route to said place of delivery, pickup or storage within the Village.

SECTION 3: Operators of said vehicles not intending to pickup or discharge cargo within the Village shall follow the designated truck route on Walden Avenue.

SECTION 4: Operators of said vehicles must deliver and pickup at the North end of Walden Avenue by utilizing the shortest route thereby entering the Village via Walden Avenue from Liberty Street adjacent to the Village of Rayland, Ohio.

SECTION 5: Operators of said vehicles must deliver and pickup at the South end of Walden Avenue and Third Street by utilizing the shortest route thereby entering the Village via Farm Lane from State Route 7.

SECTION 6: Operators of said vehicles must deliver and pick up at the South end of town by utilizing the shortest route, thereby, entering the Village of Tiltonsville via Main Street from old State Route 7 adjacent to the Village of Yorkville.

SECTION 7: Operators of said vehicles not intending to pick-up or discharge cargo within the Village of Tiltonsville entering or exiting either at the North end or South end of Walden Avenue or Main Street shall follow the designated truck route thereby taking the most direct route on the North end of Walden Avenue by utilizing Farm Lane. Route coming from the North may take Liberty Street adjacent to Rayland to North Walden Avenue and Third Street shall be made by way of Farm Lane. All truck traffic to South end of town (Main Street) shall be made by way of Old Route 7, Yorkville.

SECTION 8: Whoever violates this Ordinance shall be fined not more than \$150.00 per occurrence.

SECTION 9: That all Ordinances or parts of Ordinances inconsistent herewith be repealed and this Ordinance shall take effect from and after the earliest period allowed by law.




